You are invited to participate in the 49<sup>th</sup> Annual Pasadena Coin Club Show. The following show requirements are provided for your information. Your signature on the application indicates your agreement and acceptance to these requirements as a participating dealer.

1. Bourse table fee is \$205.00 for an eight foot table with dealer badges for self and helper, one dealer sign, backup table and night cover for the table.
2. Application for bourse table must be accompanied by at least \$100 deposit. All reservations will be confirmed. Make check payable to the Pasadena Coin Club and mailed to Box 58155, Houston, TX 77258.
3. Cases may be rented at \$10 per case.
4. Dealer setup begins at 11:00 am Friday November 26, 2010.
5. Security will begin at 11 AM. Nov 26 and will continue until last dealer leaves or 5 pm, Nov. 28.
6. Total refund will be made if cancellation of table reservation is made prior to Nov. 1, 2010.
7. Applicant shall not sell, transfer or allow another dealer to occupy an assigned bourse table without prior written consent of the show chairman.
8. The Pasadena Coin Club Show organizers and members will not be responsible for any loss by the dealers. Each dealer making application for this show agrees to hold harmless the bourse chairman, Pasadena Coin Club and its members, and the Marriott Hotel and indemnify same against all claims of liability which may arise. Dealers are responsible for their own insurance.
9. In the event the show cannot be held as scheduled, the liability of the show shall be limited to the total refund of the fee paid by the dealer prior to the scheduled show-time. The show is not responsible for acts of God.
10. Public hours for the show are as follows:
